FARMER'S MARKET VENDOR GUIDELINES

- Deadline for registration is August 30, 2023.
 - Set up time is between 7 AM and 9 AM both days of the event.
 - Vendors are responsible for their own tables and chairs and any equipment necessary for OUTDOOR set up.
 - Vendor booth size is approximately 15 feet x 10 feet.
 - Electricity is available. If needed, please indicate on registration form.
 - Most booth sites are located on blacktop and cannot be staked.
 - Booth fee is \$10 for one day or \$15 for two days.
 - If you are required to hold a Wisconsin Seller's Permit, it must be displayed at your vendor booth at the event. See **The Seller's Permit Guide for Wisconsin Farmer's Market Vendors** on the vendor page. If not required to hold a Seller's Permit, provide a Seller's Exemption Code (see below)
 - **Wisconsin Seller's Exemption Codes:**
 - Exemption Code: 1. Exempt sales only or display only
 - Exemption Code 2: Multi-Level marketing company pays sales tax
 - Exemption Code 3: Nonprofit occasional sales exemption
 - Exemption Code 4: Exempt occasional sales.
- Download DOR Publication 228 on Vendor Page to learn what your obligations are as a seller in Wisc.
- The Laura Ingalls Wilder Days Committee reserves the right to accept or reject any application.
 - The Laura Ingalls Wilder Days Committee reserves the right to deny the sale of unsuitable items. This celebration is a family event and items such as weapons, cigarettes, etc., (real or imitation) will not be allowed.
 - The Laura Ingalls Wilder Days Committee and the Village of Pepin are not liable for any loss, theft or injury incurred during the two-day festival.
 - Laura Days is a family oriented event, and, as such, booths representing an organization are to be non-partisan, not committed to the support or endorsement of any candidate for public office. No politically oriented organizations or special interest advocacy groups will be allowed booth space at Laura Days.
