## FOOD VENDOR GUIDELINES

- Deadline for registration is August 31, 2025.
- Food vendor fee is \$125.00. There will be no discount for one-day set up.
- Two ways to pay:
  - Check made payable to 'Laura Days' and mailed with printable Food Vendor Registration Entry Form to:  
P.O. Box 363, Pepin, WI 54759
  - By secure online payment link on the Vendor page on LauraDays.org (with online registration form completed and submitted)
- Set up time is between 7 AM and 9 AM both days of the event.
- Vendors responsible for their own tables & chairs & any equipment necessary for outdoor set up.
- Electricity is available. If needed, please indicate on registration form.
- In addition to a Wisconsin Seller's Permit, Laura Days requires that Mobile food vendors have all required food facility licensing issued by the State of Wisconsin. These include:
  - **Mobile Food Establishment License**
  - **Food Service Base License**
  - **Food Handler's License.**All valid licenses / permits must be posted on vendor booth or truck.
- Laura Days requires that all mobile food establishments comply with the Wisconsin Food Code requirements for Restaurants or Retail Food Establishments. Download a copy of HFS 196 Appendix on our vendor page.
- The Laura Ingalls Wilder Days Committee reserves the right to accept or reject any application.
- The Laura Ingalls Wilder Days Committee reserves the right to deny the sale of unsuitable items such as cigarettes (real or imitation).
- The Laura Ingalls Wilder Days Committee, the Pepin Peppies, Inc., and the Village of Pepin are not liable for any loss, theft or injury incurred during the two-day festival.
- Laura Days is a nonpartisan event, and, as such, no politically oriented signs or literature will be allowed to be distributed or posted at Laura Days.
- Laura Ingalls Wilder Days is an alcohol-free festival appropriate for families and young children. We respectfully ask that you adhere to this policy.
